	Half year membership fee <b>\$227.50</b>	Payable if joining between 1 Jan- 30 June 2024
	<b>Applying to become a new member – what's the total cost?</b> Total fees for new full member applying to join between 1/7/23 -31/12/23 = <b>\$595.00</b> Total fees for new full member applying to join between 1/1/24 – 30/6/24 = <b>\$367.50</b>	
Associate (Social) – Member	Annual membership fee <b>\$130.00</b>	Social Members do NOT have access to boats and are strictly non-rowing members. Payable if joining between 1 July - 31 December 2023
	Half year membership fee <b>\$65.00</b>	Payable if joining between 1 Jan - 30 June 2024
Gym Membership - Current Member	Annual membership fee <b>\$290.00</b>	Gym Members do NOT have access to boats.
Gym Membership - New Member	Joining fee <b>\$140.00</b>	Once off fee payable <u>in addition to membership fees</u> on application to become a member

- **Members who are not financial are NOT permitted to row or use any club facilities.**
- **Currently the Club is not accepting junior members (<18 years) whilst we review and implement our child safety systems.**

### **Membership benefits for ALL Full Adult Members**

- Use of boats, oars and rowing equipment (consistent with each Members competency and safety as determined by the Captain)
- Unrestricted use of the club gym and indoor rowing equipment
- Rowing Victoria(RV) registration and insurance coverage – including the ability to compete at all state and national rowing regatta's. See [here](#) for information regarding insurance coverage.
- Unrestricted access to the club house, changerooms, showers and all club facilities via a door security code
- Club sponsorship for all competing members attending up to two nominated regatta's each year [determined annually by the Committee - generally the Albert Park Lake Regatta in May and Rutherglen Regatta in Jan]. This means all regatta seat fees are paid by the Club so Member participation in APSM crews is free.
- Heavily discounted fees for hire of the clubs Function Room for your private events.
- Free and unlimited access to the '**Decent Rowing**' library of rowing coaching videos and training tips under our Club subscription. See [here](#) for information about what **Decent Rowing** has to offer.
- Attendance at club sponsored social events organised throughout the year.
- For Members wishing to store their private boat and oars at the Club, subject to availability, very reasonable boat racking fees.

### **Rowing Victoria Membership**

Rowing Victoria (RV) is the governing body for rowing in Victoria and Albert Park South Melbourne is an affiliated club of RV. All members of our Club must be registered with Rowing Victoria to be covered by personal accident insurance. Upon acceptance as a new member, and at annual renewal, the Club will ensure all members are registered appropriately and pay any associated fees as either a social or competitive rower as an integral component of your membership with the Club.

Albert Park South Melbourne Rowing Club accepts members who are also members of another RV affiliated club and permits them to nominate the club banner under which they wish to compete (although we would love it to be APSM). There will however be no reduction in membership fees for Members who nominate their RV registration under another affiliated rowing club.

### **Regatta Fees**

Members who elect to compete at state and national regatta's will incur a '*seat fee*' for each event they enter which is billed directly to the Club. These fees are set by RV prior to the event. Each member is responsible for paying their respective fees promptly upon receipt of a club invoice (and any penalties that RV may impose in accordance with their rules, e.g. late entry fees or penalties for non-attendance). **Please note** - seat fees will not be charged to Members for up to two club sponsored regatta's each year. The Club will cover the cost of all APSM crews at these nominated events, as well as all boat transport costs, as part of your membership. The Club encourages all members to compete at these regattas which cater for novice through to experienced competitors.

### **Private Boat Storage**

An annual boat storage fee of \$180.00 applies in addition to membership fees (\$90.00 if commenced after 1 Jan 2024) for each private boat that is racked at the club. Acceptance of requests for members to store their private boat at the club is not an automatic right attached to membership. Boat racking is limited and subject to annual review at the absolute discretion of the Captain.
